

NUI Travelling Studentship Scheme 2018

Frequently Asked Questions*

1. What is the NUI Travelling Studentship Scheme?

The NUI Travelling Studentship Scheme is one of the University's longest running competitions and has been in existence since 1910; it continues from an earlier scheme established by the Royal University of Ireland, which preceded NUI. It offers funding for doctoral research.

2. How many Travelling Studentships will be offered in 2018?

At least five Travelling Studentships will be offered in 2018:

- 2.1 Three** Travelling Studentships in all branches of the Humanities and Social Sciences - including Business, Law, and Psychology;
- 2.2 Two** Travelling Studentships in all branches of the Sciences, including Agricultural Science, Engineering, Architecture, Food Science and Technology, Medicine, Dentistry, Veterinary Medicine, Physiotherapy, Occupational Therapy, and Speech and Hearing Sciences.

3. Should I submit more than one application if I think my proposed research area is interdisciplinary in nature and could be considered in more than one category in Section 2 above?

4. I will be registered in an NUI constituent university for my doctoral degree. Can I still apply for a Travelling Studentship?

Yes. Students registered in NUI constituent universities are encouraged to apply if their research will require that they foster international partnerships by undertaking substantial research periods overseas as part of their doctoral studies.

5. Can I apply for a Travelling Studentship to fund a masters degree?

No. The NUI Travelling Studentship Scheme is only open to students who are planning to pursue a doctoral degree. It is not intended to fund students on taught masters programmes. However, in circumstances where universities require doctoral students to register first for a masters degree by research, these students will be considered eligible to apply. A letter from the student's university should be provided with detail of such a degree programme.

6. Can I apply for a Travelling Studentship to fund a short trip?

No. The Travelling Studentship Scheme is not intended to provide funding for one-off or short trips.

7. How long must I spend overseas to be eligible to apply for a Travelling Studentship?

Travelling Studentships have no specific minimum duration. However, the regulations require the recipient to undertake substantial research periods overseas, and the Studentships are not intended to fund one-off or short trips.

8. I have already started my PhD. Am I eligible to apply?

Yes, if you are in the early stages of your studies. 'Early stages' would usually be taken to mean the first two years for a full-time PhD student or three years for a part-time PhD student. However, there may be exceptions where, for example, the direction of the research substantially changed or a change of institution impacted on the early stages of study. 9. How do I know if I am a graduate of NUI?

You are an NUI graduate and eligible to apply if you completed a bachelors or masters degree in one of the following:

- 9.1 NUI constituent university, i.e. UCD, UCC, NUI Galway or Maynooth University.
- 9.2 NUI recognised college, i.e. RCSI (from 1977) and Uversity (from 2013).
- 9.3 Other NUI member institutions, i.e. NCAD (from 1996), St. Angela's College, Sligo (from 1978), Institute of Public Administration (from 2001).

10. I am an international student. Can I apply for a Travelling Studentship?

International students who are NUI graduates and meet the eligibility criteria outlined in the Regulations for the competition are welcome to apply for a Travelling Studentship.

11. My undergraduate / bachelors degree is not from an NUI member institution. Am I eligible to apply for a Travelling Studentship?

Yes, as long as you hold another degree (i.e. a masters degree) from an NUI constituent university, recognised college or other NUI member institution listed in Section 9 above.

12. My masters degree is not from an NUI constituent university. Am I eligible to apply for a Travelling Studentship?

Yes, as long as you hold another degree (i.e. a bachelors or a second masters degree) from an NUI member institution listed in Section 9 above.

13. My masters degree is not from an NUI constituent university. Am I eligible to apply for a Travelling Studentship?

You are an NUI graduate and eligible to apply if you completed a bachelors or masters degree in one of the following:

- 13.1 NUI constituent university, i.e. UCD, UCC, NUI Galway or Maynooth University.
- 13.2 NUI recognised college, i.e. RCSI (from 1977) and Uversity (from 2013).
- 13.3 Other NUI member institutions, i.e. NCAD (from 1996), St. Angela's College, Sligo (from 1978), Institute of Public Administration (from 2001).

14. I am in the final year of my bachelors degree in an NUI member institution and I wish to apply for a Travelling Studentship. Will you accept an application?

Yes, on the basis that you have an expectation to be awarded 1H as a whole in the bachelors degree. This expectation should be supported by at least one of your nominated referees. A copy of your final results must be submitted to NUI following the summer exam boards for your application to be considered further for shortlisting.

15. If I was awarded 1H in one or more modules as part of my degree, will this be acceptable under the eligibility criteria?

No. You must have achieved first class honours in one of your subjects as a whole, e.g. BA in French (1H) and History (2H1).

16. I have not achieved 1H in my bachelors degree but I have been awarded a masters degree by research. Am I eligible?

Yes. See Section 13 above.

17. Can my current PhD supervisor act as one of my referees?

Yes, your current PhD supervisor can act as one of your referees.

18. Are footnotes, captions, references, and bibliography included in the Research Proposal word count?

No. The maximum word count is exclusive of footnotes, captions, references, and bibliography.

19. Section 7.1.1. of the Regulations lists six points to be included in the Research Proposal. Do I need to include these six points in my Research Proposal in the order they are listed in the Regulations?

No. While these six points should be included in your Research Proposal, the layout of your Research Proposal is up to you. Candidates are advised to consult either (i) their supervisor or (ii) the Professor / Head of the relevant Department / School in advance concerning their Proposal.

20. Will a shortlisting process be applied?

Yes, a shortlisting process will apply. The research proposals included with applications are subject to independent review by two subject specialists. The results of this process help determine the shortlist of candidates for interview.

21. When do the interviews take place?

The interviews are held in the NUI offices in Merrion Square, Dublin 2 and normally take place during the summer period, usually in July .

22. When are the results of the Travelling Studentship competition made available?

All candidates are contacted by email following the conclusion of the independent assessment of the applications, usually in late June or early July. At this point, candidates will be informed if they have been invited for interview.

23. Do you provide feedback on applications?

Yes. Feedback on the assessment process and the comments of the subject specialists can be made available on request.

24. If I am unsuccessful, can I apply again?

From 2018, candidates who are unsuccessful in the Travelling Studentship competition can re-apply on one further occasion only.

Please note that this regulation affects all candidates who applied before 2017 and wish to apply again.

25. Will NUI contact me formally regarding the outcome of my application in the Travelling Studentship competition?

Yes, all candidates are regularly updated regarding the status of their application throughout the assessment process and will be contacted formally regarding the overall outcome of their application when the competition is concluded.
